In order to process this application in a timely and efficient manner, please obey the following rules:

- All fields ***FULL NAME:*** must be entered.
- If this form is not filled out electronically on your computer please make sure to use all caps (BLOCK) letters.

I understand that as a SURE Cosmetics Consultant:

- a. I have the right to buy SURE products and services for resale in accordance with these Terms and Conditions.
- b. I have the right to enroll persons in SURE Cosmetics opportunity.
- c. I will train and motivate the Consultants in my downline marketing organization.
- d. I will comply with all federal, provincial, county and municipal laws, ordinances, rules, and regulations, and shall make all reports and remit all withholdings or other deductions as may be required by any federal, provincial, county or municipal law, ordinance, rule or regulation.
- e. I will perform my obligations as a Consultant with honesty and integrity.

2. Agreement

I have carefully read and agree to comply with these Terms and Conditions (the "Terms and Conditions"), the SURE Cosmetics *Policies and Procedures* (the "*Policies & Procedures*"), the SURE Cosmetics *Compensation Plan* (the "*Compensation Plan*"), any applicable *Cross-Border Agreements* necessary if I choose to operate my SURE Cosmetics business outside of the country where my branch office exists, and the Business Entity Registration Form (where applicable), all of which are incorporated into and made a part of my agreement with SURE Cosmetics, and which shall be collectively referred to as the "Consultant Agreement" or more simply, the "Agreement".

3. No Purchase Requirements (Other than Starter Kit)

I understand that there is no financial or purchase requirement to become a SURE Cosmetics Consultant or to enter, maintain, or advance in the *Compensation Plan*. In order to familiarize new Consultants with SURE Cosmetics products, services, sales techniques, sales aids, and other matters, and for the sole purpose of facilitating sales, SURE Cosmetics requires that Consultants purchase a Starter Kit. SURE Cosmetics will sell this Starter Kit to new Consultants where price may vary depending on the market and the location but will not exceed the \$150USD price point, which is at or below SURE Cosmetics cost of same. Any products I choose to purchase, including the Starter Kit, may be returned for refund under the terms of the "Independent Consultants Buy-Back Policy," below. I understand that this Starter Kit does not contain any commissionable products and any products I choose to purchase in connection with becoming a SURE Cosmetics Consultant are optional.

4. No Earnings Representations

I agree to present the SURE Cosmetics *Compensation Plan* and SURE products and services as set forth in official SURE Cosmetics literature and in accordance with section 11.4 of the *Policies & Procedures*, including SURE Cosmetics general prohibition on income claims and earning or lifestyle representatives set out therein.

5. Engagement as Independent Contractor

I acknowledge that I am engaged under the Agreement by SURE Cosmetics as an independent contractor, and that the terms of my legal relationship with SURE Cosmetics are set out in section 4.1 of the *Policies & Procedures*. I also acknowledge that as an independent contractor, I will be generally responsible for the compliance with federal, provincial and local taxing legislation, as that legislation affects my independent business, and that SURE Cosmetics will be entitled to treat me as an independent contractor for purposes of the same legislation, and that further information regarding my tax status as an independent contractor is set out in section 4.3 of the *Policies & Procedures*.

I UNDERSTAND THAT I SHALL NOT BE TREATED AS AN EMPLOYEE OF SURE COSMETICS FOR FEDERAL OR PROVINCIAL TAX, CPP/EI, EMPLOYMENT STANDARDS, OR WORKERS COMPENSATION LEGISLATION PURPOSES.

6. Bonuses or Commissions

I understand that I must be in good standing, and not in violation of the Agreement, to be eligible for bonuses or commissions from SURE Cosmetics.

7. Remuneration for Resale of Products & for Services Rendered

I acknowledge that payment of all bonuses, commissions and other remuneration to Consultants under the *Compensation Plan* is properly construed as one or the other of (1) payment for the inherent mark-up associated with a Consultant's resale of SURE Cosmetics products and services to retail customers (i.e., the difference between what I purchase the product(s) for from SURE Cosmetics, and what I sell the product(s) for to my own customers), and (2) payments for services related to the resale of products to retail customers by a Consultant's downline (e.g., training, motivation, etc.). I understand that the basis on which bonuses, commission, and other remuneration is set out in the *Compensation Plan*, and that other relevant terms and conditions are set out here, and in the *Policies & Procedures*, including a general prohibition against payment of head-hunting and other bonuses related strictly to recruiting and not retailing SURE Cosmetics products.

8. No Inventory Loading

I am strictly prohibited from purchasing products in commercially unreasonable amounts, and my obligations in this respect are set out in section 11.3 of the *Policies & Procedures*.

9. Consultant Buy-Back Policy

SURE Cosmetics has a commercially reasonable buy-back guarantee set out in section 9.3 of the *Policies & Procedures* document. Your acceptance of this Agreement, signifies that you are aware of and have read this buy-back guarantee, and have been informed of the existence of the buy-back guarantee and the manner in which it can be exercised.

10. Amendments to Agreement

I understand that these *Terms and Conditions*, the SURE Cosmetics *Policies and Procedures*, or the SURE Cosmetics *Compensation Plan* may be amended at the sole discretion of SURE Cosmetics, and I agree that any such amendment will apply to me. Notification of amendments shall be published in official SURE Cosmetics materials. Amendments shall become effective 30 days after publication. The continuation of my SURE Cosmetics business or my acceptance of bonuses or commissions after such amendments shall constitute my acceptance of any and all amendments.

11. Term of Agreement

The term of this agreement is one year. If either I or SURE Cosmetics elect not to renew the Agreement, or if it is canceled or terminated for any reason, I understand that I will permanently lose all rights as a Consultant. I shall not be eligible to sell SURE Cosmetics products and services nor shall I be eligible to receive commissions, bonuses, or other income resulting from the activities of my former downline sales organization.

In the event of cancellation, termination or nonrenewal, I waive all rights I have, including but not limited to property rights, to my former downline organization and to any bonuses, commissions or other remuneration derived through the sales and other activities of my former downline organization.

SURE Cosmetics right to terminate a Consultant's Agreement is set out in section 13 of the *Policies & Procedures* and, without limiting that provision, is summarized as follows: (1) for breach of any terms of the Agreement, with such cancellation being effective upon notice; (2) for "Inactivity" as defined in section 13.2.1 of the *Policies & Procedures*; and upon 30 days notice if SURE Cosmetics elects to: (a) cease business operations; (b) dissolve as a business entity; or (c) terminate distribution of its products and/or services via direct selling channels.

12. Restriction on Assignment

I may not assign any rights or delegate my duties under the Agreement without the prior written consent of SURE Cosmetics. Any attempt to transfer or assign the Agreement without the express written consent of SURE Cosmetics renders the Agreement voidable at the option of SURE Cosmetics and may result in termination of my business.



*Independent Consultant Application***13. Failure to Comply**

I understand that if I fail to comply with the terms of the Agreement, SURE Cosmetics may, at its discretion take the actions set forth in section 12 of the *Policies & Procedures*, including terminating this Agreement.

14. Indemnity

SURE Cosmetics, its directors, officers, shareholders, employees, assigns, and agents (collectively referred to as "affiliates"), shall not be liable for, and I release SURE Cosmetics and its affiliates from, all claims for consequential and exemplary damages. I further agree to release SURE Cosmetics and its affiliates from all liability arising from or relating to the promotion or operation of my SURE Cosmetics business and any activities related to it (e.g., the presentation of SURE Cosmetics products or Compensation and Marketing Plan, the operation of a motor vehicle, the lease of meeting or training facilities, etc.), and agree to indemnify SURE Cosmetics for any liability, damages, fines, penalties, or other awards arising from any unauthorized conduct that I undertake in operating my business.

15. Entire Contract

The Agreement, in its current form and as amended by SURE Cosmetics at its discretion, constitutes the entire contract between SURE Cosmetics and myself. Any promises, representations, offers, or other communications not expressly set forth in the Agreement are of no force or effect.

16. Waiver

Any waiver by SURE Cosmetics of any breach of the Agreement must be in writing and signed by an authorized officer of SURE Cosmetics. Waiver by SURE Cosmetics of any breach of the Agreement by me shall not operate or be construed as a waiver of any subsequent breach.

17. Severability

If any provision of the Agreement is held to be invalid or unenforceable, such provision shall be reformed only to the extent necessary to make it enforceable, and the balance of the Agreement will remain in full force and effect.

18. Governing Law

This Agreement will be governed by and construed in accordance with the laws of the State of Delaware, without regard to principles of conflicts of laws.

19. Dispute Resolution

All disputes and claims relating to SURE Cosmetics, the Consultant Agreement, the SURE Cosmetics *Compensation Plan* or its products and services, the rights and obligations of an independent Consultant and SURE Cosmetics, or any other claims or causes of action relating to the performance of either an independent Consultant or SURE Cosmetics under the Agreement or the SURE Cosmetics *Policies & Procedures* shall subject to the laws of the State of Delaware, unless the laws of the province or territory in which you reside expressly require the application of its laws, in which case the proceedings shall be held in the capital of that province or territory. Additionally, to the extent allowed by law, you waive the right to a jury trial. Further, the prevailing party of any dispute shall be entitled to receive from the losing party costs and expenses of arbitration or litigation, including legal and filing fees. Nothing in the Agreement shall prevent SURE Cosmetics from applying to and obtaining from any court having jurisdiction a writ of attachment, a temporary injunction, preliminary injunction, permanent injunction or other relief available to safeguard and protect SURE Cosmetics interest prior to, during or following the filing of any arbitration or other proceeding or pending the rendition of a decision or award in connection with any arbitration or other proceeding.

20. Governing Law, Jurisdiction, and Venue

See section 12.5 of the SURE Cosmetics *Policies & Procedures* for detailed information.

21. Limitation Period

If a Consultant wishes to bring an action against SURE Cosmetics for any act or omission relating to or arising from the Agreement, such action must be brought within one year from the date of the alleged conduct giving rise to the cause of action. Failure to bring such action within such time shall bar all claims against SURE Cosmetics for such act or omission. Consultant waives all claims that any other statutes of limitations applies.

22. Authorization

I authorize SURE Cosmetics to use my name, photograph, personal story and/or likeness in advertising or promotional materials and waive all claims for remuneration for such use.

23. Electronic Agreements & Facsimile

If you are submitting this application online, you acknowledge and agree that by clicking on the icon/button labeled "Submit," "I Accept" or such similar icons/buttons as may be designated on the online application to accept the Terms and Conditions of the Agreement, you are submitting a legally binding electronic signature and entering into a legally binding contract with the SURE Cosmetics.
